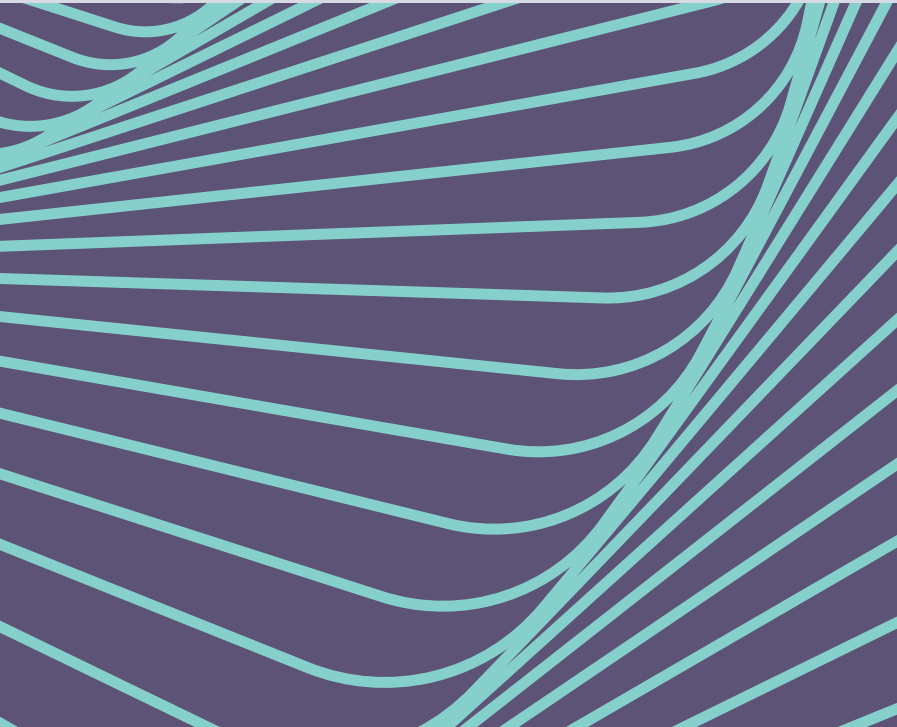

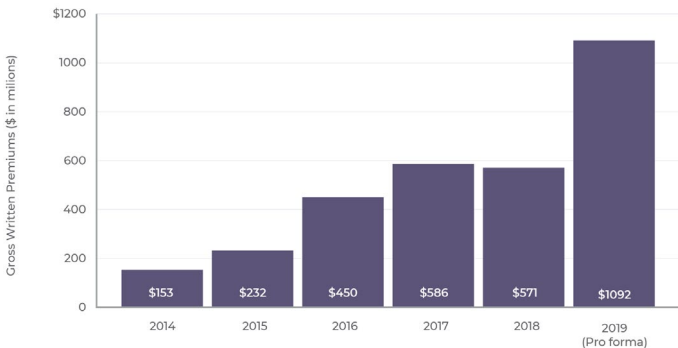
Some highlights:
