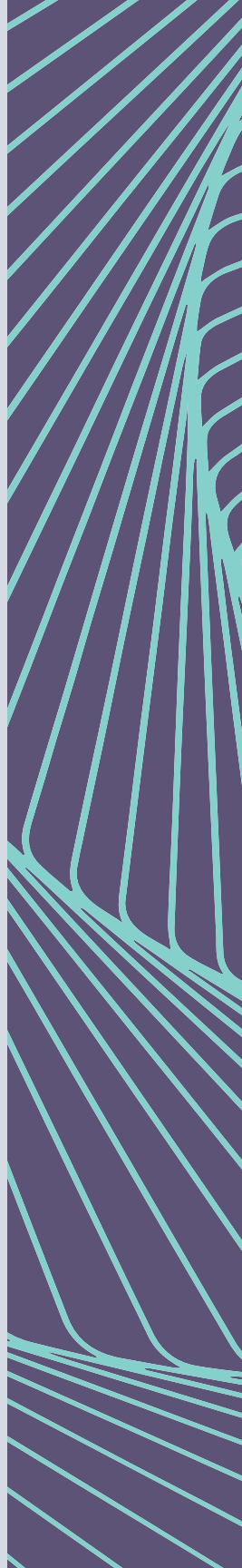

Hamilton ILS is Hamilton's third-party capital platform.

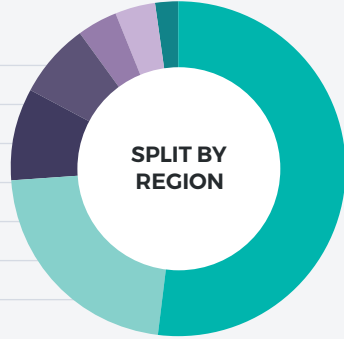

Split by line of business

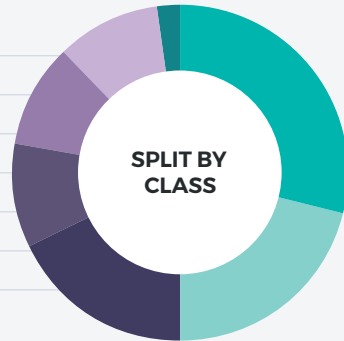

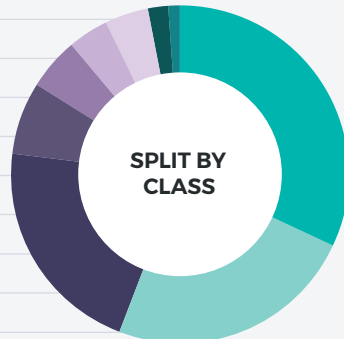
